2. SKIER/SNOWBOARDER TYPE:

- II **INTERMEDIATE** - skis/boards moderately, prefers variety of speeds, skis on varied & expert terrain.
- III **ADVANCED** - skis/boards aggressively, skis at high speeds, prefers steeper & more challenging terrain.

3. SKIER/SNOWBOARDER TYPE:

- Regular Stance (left foot forward)
- Goofy Stance (right foot forward)
- Snowblades (limited quantities available) (driver's license or credit card deposit required)

4. RELEASE & IDEMNIFICATION:

I accept **As Is** the equipment listed on this form, and accept full financial responsibility for the care of the equipment while it is in my possession. I will be responsible for the replacement at full value of any equipment rented under this form, but not returned to the BUTTERNUT rental shop. I agree to return all rental equipment by the agreed date. I understand that the binding release system cannot guarantee the user's safety. In downhill skiing, the binding system will not release at all times or under all circumstances where release may prevent injury or death, nor is it possible to predict every situation in which it will release. In snowboarding, skiboarding and snowblade use, the binding system will not ordinarily release during use; bindings are not designed to release as a result of the forces generated during ordinary operation.

I understand that the sports of skiing, snowboarding, snowblading and skiboarding and other recreational activities involve inherent and other risks of INJURY and DEATH, I voluntarily agree to assume all risks of injury or death that may result from skiing, snowboarding, snowblading and skiboarding use, or which relate in any way to the use of this equipment.

I AGREE TO RELEASE the Butternut Basin Rental Shop, Butternut Basin Inc., its employees, owners, affiliates, agents, officers, directors, and the manufacturers and distributors of this equipment (collectively "Providers"), from all liability for injury, death, property loss and damage which results from the equipment user's participation in the sport of skiing, snowboarding, snowblading and skiboarding use, or is in any way related to this equipment, including all liability which results from the NEGLIGENCE of PROVIDERS, or any person or cause. I further agree to defend and indemnify PROVIDERS for any loss or damage, including any that results from claims or lawsuits for personal injury, death, and property loss and damage related in any way to the use of this equipment. This agreement is governed by the State of Massachusetts. If any provision of this agreement is determined to be unenforceable, all other provisions shall be given full force and effect.
